Summary of Findings:

Students demonstrated competency in obtaining knowledge of the learning standards indicated in this outcome/measure. Specifically, students in the COUN 6980 course obtained an average score of 3.3/4, and students in the COUN 7010 course obtained an average score of 3.4/4. This demonstrates competency in the appropriate use of diagnostic processes and the use of diagnostic classification systems. These findings are based on data reported to the program by instructors of the COUN 6980 and the COUN 7010 course.

Action details:

The program is transitioning its curriculum to align with the 2024 CACREP Standards. In doing so, program faculty have reviewed its learning objectives and methods of assessing them. The learning objective stated in the current "Year 5" outcome states that "Students will demonstrate knowledge in specific program areas (i.e., Clinical Mental Health, School, College Counseling and Student Affairs)." The program will maintain this as a learning objective of the program but will update the assessment method to more accurately capture data related to the outcome. Specifically, instead of only collecting/analyzing data from two CMHC courses (COUN 6980 and 7010), we will now collect and analyze data from courses within each specialty program area.
